In reference No.1 to 3 above, I am the Education Officer (Prath) Z.P. Dhule giving the first approval certificate to the concerned school to start a new school for the academic year 2018-19 on self-financed basis on the following terms and conditions.

Terms and Conditions :

1. According to Reference no. 1 to 3, medium and place specified by School during recognition cannot be changed in future.
2. If a school is started at a place other than the place for which permission has been given by the government, the permission given by the government will automatically be considered cancelled. As per the provisions of this Act, approval for establishment of schools shall be from the academic year 2019-20.

3. If your society has proposed two or more new schools of pre-primary/primary/higher primary/secondary/higher secondary schools simultaneously and in the same place or two new schools of different mediums in the same place and two or more of them, As Per Government decision dated 3 November 2018 Only one new primary school at the lower level can be started if permission is obtained under it and the lowest class of that school can be started from 2019-20 onwards. Subsequent classes will be allowed to start in a phased manner with natural growth.
4. In the academic year 2019-20, no higher class can be started other than the class which is allowed An otherwise initialized upper class cannot be initialized. Upper classes initiated otherwise will be treated as unauthorized.
5. As per RTE 2009 norms, it will be necessary to appoint qualified teachers/non-teaching staff to those posts on the basis of number of seats from time to time by the concerned authority on the basis of the number of seats and get personal approval from the Education Officer (Primary) of your district.
6. The new schools granted permission shall comply with the orders issued by the Government from time to time, the procedure and all the provisions of the RTE 2009 and the Maharashtra Self-financing Schools (Establishment and Exchange) Principal Rules 2013.
7. In the future, if the documents submitted along with the proposal for starting an internal school in Self-help Aided Schools (Establishment and Exchange) 2012 are found to be not legal, the approval proceedings given under the Government Decision dated 03 November 2018 should be considered as null and void.
8. It shall be mandatory to put up a board in front of the school building for the information of all the public indicating that the new school / class eligible for permission on Self-Meaning Aided principle and correspondence made from time to time shall be written as Self-Meaning Aided School and Class.
9. Maharashtra Self-Help Aided Schools (Establishment and Regulation) Act, 2012 It will be mandatory for schools recognized under this Act to enter information in U-DICE separately as self-help aided schools or classes.
10. It will be binding on the institution as well as the school to implement all the prevailing rules of the government regarding the running of the said school and all the rules that the government may prescribe from time to time.
